Additional payment for high-quality, affordable care, split between the provider and ilumed.

A quick note


These visuals show how ACO REACH works in two different payment models:

- Provider A represents monthly capitation rate (MCR)
- Provider B presents enhanced fee-for-service (EFFS)

Each ACO REACH provider contract is unique. These examples show two hypothetical percentage breakdowns across all three payment types for a fiscal year. Your results may vary.


Base payments

Providers can either opt to receive a monthly capitation rate per patient per month or an enhanced fee-for-service rate from ilumed, both of which are an average of 30–50% higher than Medicare's physician fee schedule. Higher base rates mean providers have more predictable cash flow, which allows them to reinvest in their practice, infrastructure and staff.



Quality bonus payment


Phenomenal care deserves recognition. The ACO REACH model offers a quality bonus payment to incentivize and reward remarkable value-based care. When your patients' health improves as shown by ACO REACH quality measures, so should your bottom line.



The total quality bonus payment a provider can earn is based on their base payment type as well as performance indicators in six categories. These are hypothetical examples. Your results may vary.
